#### **NEW BUSINESS**

## Adoption of the Agenda and Approval of Minutes from June 2021

A motion was made to Adopt the September 2021 Agenda and Approve the June 2021 Minutes by Kevin Byrd with a second by Rita McClenny. Vote passed.

**People Inc Agreement with Cultural Center** – Erik provided an overview of the updated People Inc agreement. Contract was provided in Board Packet. The following is the main change to the agreement:

"WHEREAS, the Reserve Fund Cap of \$1,283,200 is the required collateral maintenance level, the parties hereto desire to modify the description of the collateral encumbered by Notes to reflect that the Reserve Fund Cap is a target and shall not be required to be maintained on an amortized payment schedule, provided that by September 30th of each year (beginning 9/30/2022) Borrower make an annual payment into the Reserve Fund equal to two and a half (2.5) percent of the difference between the Reserve Fund Cap and the Reserve Fund balance as of June 30 of each year, net of any encumbrances such as amounts being used as loan collateral."

The Reserve Fund Cap is \$1,283,200. Currently, the Reserve Fund Balance is \$675,000. The difference from the Reserve Fund Cap to Reserve Fund Balance is \$608,200, and 2.5% of the \$608,200 difference is \$15,205 (amount due in September 2022.)



#### **EXECUTIVE DIRECTOR REPORT** – Kim Davis

- Kim Davis gave an overview of her first 2.5 months with Friends.
- Cultural Center has expanded hours and open six (6) days per week.
- ARC Event Update Erik/Kim gave an overview of the ARC Conference coming to St. Paul and Abingdon October 4-5, 2021.
- Tenant recruitment Ended contract with local real estate agent in August. No leads or results had been produced in the first six (6) months of the contract.
- Partnership Program Discussed the Partnership Program report. This report was distributed in the Board Packet and reviewed.
- Marketing Update –Friends is working with Lori Worley with the High Road Agency for a few months to assist with Public Relations. High Road will assist with press releases, e-newsletters, and assisting Chad with building relationships with local media.
